December 6, 2014 ASC Chair Report

Thank you for allowing me to serve as your ASC Chair.

A few issues were brought to my attention this month. The Admin Committee held a meeting this month to discuss these issues and possible solutions. These issues included the calendar ad-hoc project, removing individuals from elected or appointed positions for non-compliance, and the public relations subcommittee.

The calendar ad-hoc project is being folded into Activities and handled through merchandise going forward.

The ASC guidelines are clear when it comes to removing individuals from elected or appointed positions for non-conformity. Section 6.9 states that a motion for non-compliance may remove an elected ASC member. There were two positions that caused this body many discussions over the last several months. One of the positions is up for election next month and will become moot. The other position, Outreach Liaison, has not been filled since February. The position was up for election in February and it looks, after reviewing prior minutes, as if I failed to call for nominations to fill that position. This was my error at the time and I have continued to neglect filling that position with an appointment. This was my oversight and I apologize to this body.

The public relations committee has been having problems with efficiency during the subcommittee meetings, H&I panels not being held consistently, and issues with the phone line. The Admin Committee has agreed that we will help the subcommittee in any way we can, beginning with attending the subcommittee meetings and being available for questions and help.
